TREASURER'S REPORT: Treasurer Bill Herman reported that as of September 16, 2020, Gross Profit for August, 2020 is \$194,247.80, Expenses \$244,220.67, Net Income Loss -\$49,972.87. Las Moras Gross Profit is \$1,773.01, Expenses \$1,490.84, Net Income of \$282.17. Restricted Fund Net Income is \$3,072.89. Profit and Loss for Fort Clark Springs, October through August, 2020, is Gross Profit \$2,001.972.89, Expenses \$2,291,222.59, Net Loss -\$292,518.18. Profit and Loss for Las Moras, October through August, 2020, is Gross Profit \$21,350.47, Expenses \$28,590.82, Net Loss -\$7,225.25. Restricted Fund, October through August, 2020, Bank Balances Texas Community Bank Checking \$42,142.80, Credit Card \$68,301.64, Money Market \$8,593.67. All department managers have action plans to work on for the next month. Landscaping contract has expired and we are now hiring in-house for a Landscaper Supervisor and Crew Member. The trapping of deer ends on September 30th. We will be looking at ways to do the trapping in-house in the future. State Fair of Texas is hosting a virtual Fair September 25-October 18. We will be participating in this. Other events coming are an Employee Picnic on September 28, Golf Cart Parade on October 30, 1st Annual Holiday Arts & Crafts Fair on November 7.

Golf Committee – Katie Brown: Shrimp Boil brought in \$8,600.00. The Committee bought valves, asphalt, flag sticks and cups. \$4,600.00 was raised for the family of a deceased employee. The Committee awarded two \$1,000.00 scholarships for the BISD Seniors. October 17th will be the 1st Ladies Las Moras Tournament. October 31st will be the Halloween Tournament which is co-sponsored with KCCA (Kinney County Church Alliance), which feeds seniors and families along with helping families in emergency situations. This is the only fundraiser KCCA will do and it helps the costs for one year. A reminder from President Sandee Hagen for the Golf Committee to review and update the By-Laws for the Golf Committee.

<u>Preservation Committee - President Sandee Hagen for Linda O'Brien</u>: The Preservation Committee is waiting for the Commissary to dry out. MK will be starting work soon. The stone walls have been completed with two areas near the empty saddle, cemetery and the motor pool.

**Recycle Committee - Helena McBride**: August shipment made \$277.00. Waste Management Truck was \$564.42 based on February and August shipments. Working with Philip to see if there is another way to ship. We will be sending cardboard off soon and that will be a positive sum. Cat food cans are aluminum.

<u>Las Moras Restoration Project - Helena McBride</u>: (From Chris Hale, Committee Chair.) A Grant application was submitted last month seeking funding for detailed engineering analysis for the structural repair to the pool and spring enclosure. This will include cost estimates. Las Moras Historical Marker has been repaired. Kinney County Historical Commission and Fort Clark Historical Society are working together to find an optimum location to avoid repeated vandalism and maximizing visibility.

<u>COMMUNITY COUNCIL REPORT – Kathi Warm</u>: Community Council had its first meeting of the fall on September 12th. October 3rd will be Creekside Patio Cleanup. Volunteers are welcome. 8 to 11 a.m. with a light lunch following. Next cleanup will be in Unit 15 in November. Honor Society High School Students may be asked to help. The November movie will be inside and possibly have two showings.

## **OLD/UNFINISHED BUSINESS:**

Action Item 1: 2020-2021 Assessment Recommendations. The recommended assessment increase was based on CPI (Consumer Pricing Index). The assessment would be for \$1.00, which is for 2 years. Increase will be in effect October 1, 2020. Directors' Comments. Members' Comments. EO/GM Alan Peterson made a comment on the equipment. We are spending more to keep it up than what it would cost for new equipment. Motion for assessment increase of \$1.00 per membership by Treasurer Bill Herman. Vice President Dustin Smith 2nd. Motion passes - 3 for and Director Reanna Hay against, less one absent Director.

EMAIL VOTES: Approval of Esten Mullins to the Airport Committee. Email votes passed unanimously.

EMAIL VOTES: Credit Card Convenience Fees. FCSA pays thousands of dollars in credit card fees. This vote was for the members to start paying the credit card convenience fees. Motion passed unanimously, less one absent Director.

Action Item 1: Create Ad Hoc Financial Advisory Committee. Directors all agreed with the Executive Officer and General Manager that we do not need a Financial Committee at this time. Member comments. Motion was made to not have an Ad Hoc Financial Advisory Committee by Treasurer Bill Herman. Vice President Dustin Smith 2nd. Motion passed unanimously, less one absent Director.

Action Item 2: Approve Employee Health Insurance Policy for 2020-2021. This item is tabled until the Directors receive all the information from Troy Persyn. Treasurer Bill Herman Motioned for this item to be tabled. Vice President Dustin Smith 2nd. All Directors voted unanimously, less one absent Director.

Action Item 3: Approve Budget for Fiscal Year 10/2/2020 to 9/30/2021. Executive Officer/General Manager Alan Peterson reported on the new Budget. He looked at the 2018-2019 Actuals and listed previous budgeted amounts. 2078-2018 \$2,233,669.00, 2018-2019 \$2,437,009.00, 2019-2020 \$2,517,732.00, and 2020-2021 \$2,522,000.00. Expenses with payroll being the largest expense - 2017-2018 \$1,133,000.00, 2018-2019 \$1,058,750, 2019-2020 \$1,102,209, 2020-2021 \$1,169,600. Electricity will be a little bit lower. We are not using as much and have some deals to lower costs. Insurance will be a major increase for this year. Total Expenses for 2017-2018 \$2,683,716.00 for a loss of -\$450,000.00, 2018-2019 \$2,659,810 for a loss of -\$222,000.00, 2020-2021 \$1,387,000.00. This will be a tight budget after looking at the last five years of history. Each department will have a monthly budget. There is a plan to open a restaurant at Creekside. Directors' Comments. Board of Directors will monitor and review every quarter. Treasurer Bill Herman Motioned to accept the newly proposed Budget. Vice President Dustin Smith 2nd. Motion passed unanimously, less one absent Director.

Action Item 4: Approve Election Committee Members. President Sandee Hagen reported that one member has come forward to submit their name to be on the Committee. Six others are interested. Motion passed unanimously, less one absent Director.

Action Item 5: Money Market Account Changes. This account is dormant and has \$8,593.61 in the account. Directors discussed if they should leave in the money market account and reactivate it or move the money to a Texas Community Bank account. Directors' Comments. Vice President Dustin Smith Motioned to maintain and reactivate the money market account with \$100.00 per month. Director ReAnna Hay 2nd. Motion unanimously, less one Director absent.
