### **NEW BUSINESS/ACTION ITEMS:**

Agenda Item 1: Consider Approval for Variance for Unit 25, Lot 28. 4 Variances are being asked from owners. 1 - Setback in back of property for about five-six feet of roofline and two-three feet for the house; 2 - The living space for that unit is 1500 square feet and the variance is for 1376 square feet; 3 - Use a horizontal hardy plank siding, which is not in the CC&R's; 4 - Enter driveway off of Pecan Road. President Lisa Vale gave a history of the property. Director Comments. Member Comments. Motion was made to approve the variance with a documented square footage of the encroachment within the common property and that the driveway is constructed of concrete to be met with minimal requirements of light duty pavement and able to enter property off of Pecan Road instead of Oak Lane due to a 100 year old tree that will be damaged if a driveway is build off of Oak Lane, plus living space under 1500 square feet, and the use of horizontal hardy planks by Director John Wylie. 2nd by Vice President Memo Guzman.
